**Unified Greeley County Offices (including the Greeley County Courthouse)** will be locked to the general public and admission will be limited on a discretionary "as needed" basis by appointment only. All individuals of the public requesting access to the building will be subject to a Health Questionnaire developed by the local Public Health officer. If any question is answered in the affirmative, access shall be denied. Access shall be restricted to one individual of the public at a time. Any individual of the public requesting access must contact the respective department to schedule an appointment. Restricted access shall not apply to persons attending court hearings in accordance with Kansas Supreme Court Administrative Order 2020-PR-16. All County employees will continue to maintain normal business hours and perform assigned tasks until further notice. These directives are clearly established in Resolution 2020-005, passed by the Unified Board of Supervisors on March 19, 2020. The following offices are included:

When using the drop box or mail in, you will need to include: renewal notice, proof of insurance (that can be faxed from your agent) and payment. We will be taking appointments for title work and IRP Only. You will need to call the office for that appointment. If you need to conduct critical business that requires an in-person meeting, please call for an appointment to confirm access to the facility and availability of staff.
- We ask you to call ahead for product pickup whenever possible, our team will ensure that everything is ready to load upon your arrival.
- For those customers or vendors delivering grain or picking up products, we ask that you limit your time in the office to essential business. At some locations, we are asking drivers to remain in their cab. Please check our location policies or watch for information and direction upon arrival.
